Water Safety Awareness Program



Keeping young children safe in and around the water is vital

Water safety awareness is an important life skill, and combined with active supervision it helps keep young children safe.

The Water Safety Awareness Program provides free water safety lessons for parents/guardians and their children under five.

What does the program include?

The program is accessible in two ways to ensure young children in all parts of the Territory can participate.

1. The urban/rural program includes five practical sessions for parents and their children. The sessions teach emergency care, revival skills, water awareness and familiarisation, with activities both in and out of the water.
2. People who select the remote area program will receive a DVD about emergency care and revival skills. Three in-water sessions are then completed with a registered provider of the program or when Royal Life Saving NT is visiting the area.

Who qualifies for the program?

Every parent and guardian caring for a child under the age of five in the Territory can access the program.

Parents and guardians must participate in the water sessions with their child and all sessions must be completed before the child turns five.

How do you access the program?

Simply complete and return the attached registration form. Alternatively you can register online at www.watersafety.nt.gov.au

After you register, you will receive information on how to complete session 1 which teaches important emergency procedures and resuscitation skills. Upon completion of session 1 you will receive your practical session 2-5 vouchers as well as a list of registered providers approved to deliver the program.

Remote program participants will also receive a DVD.

It is your responsibility to contact these providers and book into their sessions.
