| Summary: | This Circular contains the relevant details for entering competitors into the Australian Surf Boats National Team Selection for the 2026 Trans-Tasman Surf Boat Test Series | | |

BACKGROUND

Each year Surf Life Saving Australia and Surf Life Saving New Zealand select an Open Male, Open Female, U23 Development Male & U23 Development Female surf boat crews to represent their country in the annual Trans-Tasman Surf Boat Test Series.

The 2026 Trans-Tasman Surf Boat Test Series will be held on Saturday 14th February at Wanda Beach, NSW with the 3-test series to be run alongside the ASRL Open.

To be considered for selection, crews must enter and attend the Australian Surf Boat Team selection event at Blacksmiths Beach, Swansea Belmont SLSC on 12th December 2025. Note, your entry indicates your nomination for selection and deems eligibility for the Trans-Tasman Surf Boat Test Series.

SELECTION

Victorious crews of the selection events must be Australian Citizens, current, financial members of SLSA and in good standing with the organisation for their selection to be considered by the selection panel as per 2025 26 Trans-Tasman Surfboat Selection Guidelines.pdf.

Upon entering this selection event, all crews are agreeing to Australian Lifesaving Team Selection Guidelines. All crew members are also agreeing to attend any media requirements or team functions as outlined below, as well as confirming their availability to attend the 2026 Trans-Tasman Surf Boat Test Series will be held on Saturday 14th February. If any member fails to meet these requirements the selection panel will then consider the results of racing at the selection event and announce a replacement team in accordance with the 2025 26 Trans-Tasman Surfboat Selection Guidelines.pdf

Prior to the selection event, all teams and team members must have read and understand the <u>2025_26</u> Trans-Tasman Surfboat Selection Guidelines.pdf.

SELECTION PANEL

The Selection Panel will be responsible for the selection of crews to represent Australia at the 2026 Trans-Tasman Surf Boat Test Series. A Surf Boat panel advisor may be appointed to the Selection Panel to assist with selections but will not have voting rights.

Selection of the Australian Team will be decided following the conclusion of the trial event at Swansea Belmont SLSC on Friday 12th December. Please allow time for this process to followed and ensure that selected team remains onsite after racing for a team meeting once selected.

The 2026 Team Managers will also be present at the selection event.







TEAM COMPOSITION

- Open Male Crew (Australian Capped Team Representative)
- Open Female Crew (Australian Capped Team Representative)
- U23 Male Crew (Australian Development Representative)
- U23 Female Crew (Australian Development Representative)

PLEASE NOTE

- Open Male and Open Female Crews will receive an Australian Life Saving Team (ALT) Cap Number and Blazer.
- All team members are required to complete the ALT Online Induction in order to accept their position on the team and complete all required documentation by the indicated deadline.
- As with the majority of Australian Life Saving Team tours, those athletes selected will be required to assist with tour costs (accommodation, outfitting, meals etc.) in form of a levy. The following levies to be paid towards this tour;
 - Selected U23 Male and Female Development Crews will be required to pay a \$500pp levy.
- In nominating for and being selected in the Australian Surf Boat Teams all team members are required to participate in all team activities and stay in team accommodation for the duration of the Trans-Tasman Surf Boat Test Series tour.
- All selected crews will need to be available the afternoon of Thursday 12th February for a formal presentation and team meeting at SLSA Head Office at Bondi Beach.
- The team will travel to Wanda following the team presentation at Bondi.
- There will be a formal team dinner between the Australian & New Zealand Teams on Friday 13th February.
- Accommodation for all crews will be provided near the competition venue from Thursday 12th Saturday 14th where they will check out of the team following the conclusion of racing.

INTERSTATE COMPETITION

To enhance the Australian Life Saving Team experience and after extensive consultation, it was endorsed by the States that crews selected to represent Australia at the 2026 Trans-Tasman Surf Boat Test Series will be ineligible for selection to represent their State team chosen to compete in the Interstate Championships to be held at Wanda on Friday, 13th February.

SELECTION EVENT FORMAT

ROUNDS

- All teams will compete in three round robin races
- Following the first three round robins, all division will be cut to the top 8 crews based on point score
- An additional two round robin races for top 8 crews will be seeded by point score. Point score continues from first three rounds.
- Following the last round robin race, three crews will be taken to the final series based on point score from all five races
- At the completion of the Round Robin racing any crews on equal points who are in contention to qualify for future racing, or to determine an overall final result (if no finals are planned to be conducted see notes below), result shall be decided on the following basis:
 - a) The crews involved will be compared firstly on head-to-head results, with the winner of the head-to-head qualifying to the next (elimination) round of racing. For example, if Crew A and Crew B only raced each other in heat two of the second round and Crew A beat Crew B in that race, then Crew A will qualify for the next round.
 - b) If the crews have not raced each other, or are still equal after comparing head-to- head results, the relative places from all round robin racing will be reviewed and the crew with







- the highest individual placing will proceed over the other crews. For example, if one of the crews on equal points has a first place, they will proceed over other crews who did not receive a first place in the rounds. This comparison will continue for second, third etc., places until there is a clear qualifier.
- c) If the crews are still equal after both of these comparisons, then the round robin result will be declared a dead heat between the crews involved (as per Rule 2.24). All crews achieving the dead heat will share the round robin finish result and/or be allowed to progress in the competition.

FINAL SERIES

- The Final Series will consist of three rounds, with all three crews required to compete in all three races
- A new point score will apply specifically for the Final Series. Crews will move one lane up each race
- In the event of a **tie** after the three rounds, a **sudden-death race-off** will be conducted between the tied crews only.

POINTS

Points will be allocated as per the Surf Sports Manual for Round Robin Racing:

| 1st place | 10 points |
|-----------------------|-----------|
| 2nd place | 9 points |
| 3rd place | 8 points |
| 4th place | 7 points |
| 5th place | 6 points |
| 6th place | 5 points |
| 7th place | 4 points |
| Did Not Finish (DNF) | 3 points |
| Did Not Start (DNS) | 0 points |
| Disqualification (DQ) | 0 points |

ENTRY PROCESS

Club entries to the Australian Surf Boats National Team Selection Event must be submitted via the SLSA Sports Event Management System (SEMS). Instructions for entries can be found via the following <u>SEMS</u> Guide.

ELIGIBILITY TO COMPETE

To be eligible to compete, competitors must comply with Policy 5.04 – Competition Eligibility and the Guidelines for Competition Eligibility document (available on the SLSA Members Area). If the requirements of Policy 5.04 are not met for the current season by 31st December, the team member will be withdrawn from the team.







ENTRY FEES

The Australian Surf Boat National Team Selection entry fees are as follows:

PAYMENT

Clubs will be sent an invoice after each entry period. Clubs MUST pay by Wednesday 10 December. Clubs must include club name and invoice number when paying total amounts.

CLUBS WITH UNPAID ENTRY FEES WILL BE INELIGIBLE TO COMPETE.

REFUND OF FEES/CANCELLATION FEES

Once an invoice has been generated, entry fees are non-refundable.

TEAM CHANGES

Changes to already existing team entries can occur up until Entries close at 11:59pm (AEDT), 1 December 2025 via SEMS.

MEMBERSHIP REQUIREMENTS

Each competitor must hold the award relevant to their entry and have completed a proficiency test for the award. The details of these requirements are detailed in SLSA's Policy 5.04 – Competition Eligibility and the SLSA Guidelines for Competition Eligibility document via the SLSA Member's Area. As noted under Eligibility to Compete see above for further details.

RESTRICTIONS ON EVENTS AND PROVISOS

The following restrictions shall apply in regard to nominations and competition in the various events:

- a) Rule 2.10.2(a) New note 2: Substitution rules for surf boats are contained in Section 5
- b) Rule 2.22(f) for dry finishes
- c) As detailed in Note 1 of Section 5.1(a) of the of Surf Sports Manual only accredited S3 and S2 Sweeps will be eligible to sweep surf boats in these Championships. For further information please refer to the SLSA Sweep Accreditation Document.
 12 Month Trial period "Where a S3 sweep replaces a S2 sweep due to Surf Risk Rating is 16 or above, the first preference is for a replacement from within the same club. However, a sweep from another club will be considered if there are no suitable replacements. Any points acquired by the crew will be fully allocated to the entry crew and club, with no points and/or final placings achieved going to the sweep or the club of the substitute sweep. If conditions abate during the event the original S2 Sweep must return for the crew to continue racing."
- d) Surf Boat Competitors are reminded to refer to the Surf Sports Manual Section 5.1(a) Note 3-5 above that details particular 'double dipping" rules that apply to the Australian Surf Life Saving Championships. Notes 3-5 above. The alternative rules relate to 'Double dipping' (i.e. competing in more than one division or age category of rowing) by crews will not be permitted at the Australian Surf Life Saving Championships). Exceptions to this condition are as follows: New Note 7(iii): Should a member of any crew become indisposed they may be replaced subject to approval of the Carnival Referee provided the replacement crew member complies with the requirements contained in Sections 2.13 and 2.18 of the Surf Sports Manual and any special entry requirements. Once a crew member has been replaced, they are ineligible to re-enter competition within the event unless:







- (a) A medical practitioner certifies the competitor fit to resume competition; and
- (b) The Referee approves the reinstatement.
- e) Please note Section 5.1 (f) of the Surf Sports Manual re the mandatory wearing of helmets in Surf Boats unless an acceptably low-level risk is assessed.

COMPETITION MANIPULATION

The SLSA <u>Policy 5.11 – Competition Manipulation and Gambling</u> covers all surf life saving events that are conducted by SLSA, State Centres, Branches and Clubs includes special events, conducted by third parties sanctioned by an SLS entity and any event, competition or series connected with Surf Lifesaving.

ANTI-DOPING & MEMBER PROTECTION

Members participating in the Australian Surf Boat Selection event have responsibilities under SLSA Policies, specifically Policy 5.02 Australian National Anti-Doping Policy and Policy 6.23 Improper Use of Drugs and Medicine in Sport.

It is strongly recommended that all participants including competitors, team managers and sweeps complete the online Sports Integrity Australia training module Anti-doping Fundamentals as a minimum prior to the selection event. https://www.sportintegrity.gov.au/resources/education.

Athletes selected on the Australian Life Saving Team will be required to complete the following Sport Integrity Australia Courses as part of the Team Induction:

- Anti-doping Fundamentals
- 2026 Annual Update
- Competition Manipulation and Sport Gambling

In addition to the above Sport Integrity Australia Courses, team members are required to also compete the following SLSA Courses;

- SLS Childsafe Awareness
- SLS Sexual Harassment and Misconduct Awareness
